Articles of Amendment

<u>VOTED</u>: To authorize amendments to Articles 4A(8) and 4B of the Corporation's Articles of Organization as follows:

4A(8) to have and exercise all powers necessary or convenient to effect any or all of the purposes for which the corporation is formed; provided that no such power shall be exercised in a manner inconsistent with the general laws of the Commonwealth of Massachusetts, or with section 501 (c) (6) of the Internal Revenue Code of 1954, as amended (the Code).

4B. Prohibited Activities.

- (1) The corporation shall neither have nor exercise any power, nor shall it engage directly or indirectly in any activity, that would invalidate its status as a corporation which is exempt from Federal income taxation as an organization described in Section 501 (c) (6) of the Internal Revenue Code of 1954.
- (2) No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 2. hereof.
- (3) No substantial part of the activities of the corporation shall consist of carrying on propaganda; nor shall it in any manner or to any extent participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of any candidate for public office; nor shall the corporation engage in any activities that are unlawful under applicable Federal, State, or local laws.
- (4) The corporation shall not operate for the purpose of carrying on a trade or business for profit.
